CITY SNOW REMOVAL NOTICE



All City of Chicago businesses and commercial property owners are required, under Municipal Code, to remove snow and ice from sidewalks abutting their property or business (Section 4-4-310 and 320). Business owners should clear a path of at least 5 ft. in width. It is also important to remember that a sidewalk free from snow and ice is provision of your business license (Section 4-4-320 and 10-8-180).
